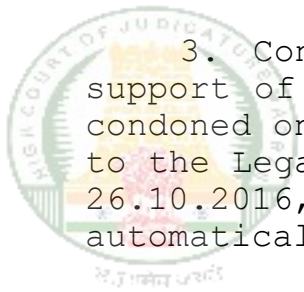
PRAYER IN CMA(MD) NO.6873/205 :
