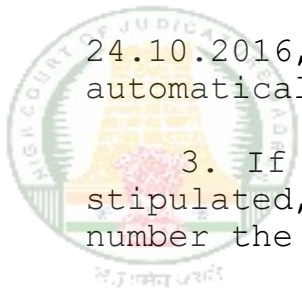
Prayer in CMA(MD)SR1867 of 2016:
