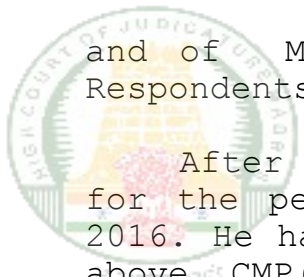
PRAYER IN WA(MD)NO.SR7444/2016 :

Prayer in WP(MD). 23016/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the 2nd Respondent to consider petitioner representation for surveying the land and issue separate patta for the land comprised in Patta No.683 in the light of the direction given by the 1st Respondent in his proceedings in O.Mu/A2/10479/2015 dated 24.06.2015 within the time limit that may be stipulated by this Hon'ble Court.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S. G.THALAIMUTHARASU, Advocate for the petitioner



and of MR.A.K.BASKARAPANDIAN Special Government Pleader for the Respondents the court made the following order:-

After making submissions, Mr.G.Thalaimutharasu, learned Counsel for the petitioner seeks permission to withdraw CMP(MD)No.2187 of 2016. He has also made an endorsement to that effect. Recording the above, CMP(MD)no.2187/2016 is dismissed as withdrawn.
