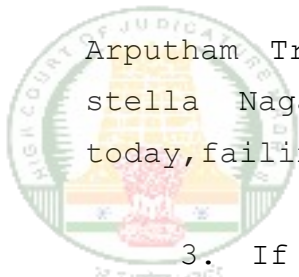
Prayer in CMA(MD)SR.53715 of 2015:
