PRAYER IN WA(MD) No.SR41474 of 2015:

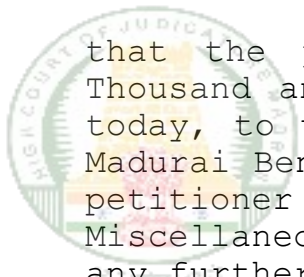
Writ Appeal against the order in WP(MD)No.1226 of 2010 dated 03.07.2014.
