PRAYER IN CRP(MD)No.SR2875 of 2016:

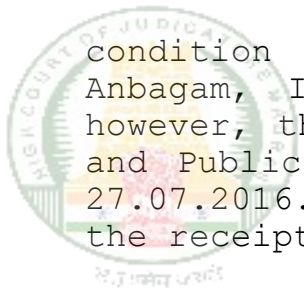
