This petition has been filed to condone the delay of 828 days in filing the above appeal.

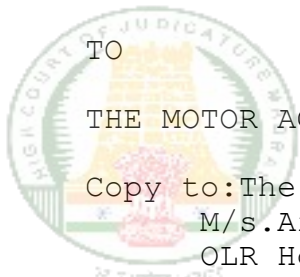
