This petition has been filed to condone the delay of 105 days in filing the above appeal.

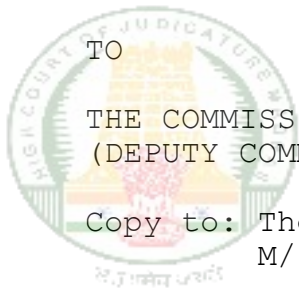
2.Though notice was served on the respondent No.2 and his names also printed in the cause list he has not chosen to appear either in person or through counsel.
