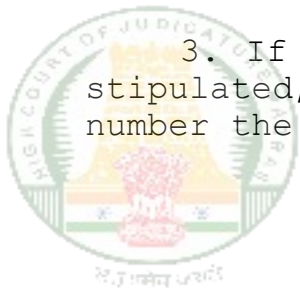
PRAYER IN CMA.SR.No.40015/2013 :
