"Being satisfied with the reasons stated in the affidavit, this petition is allowed.

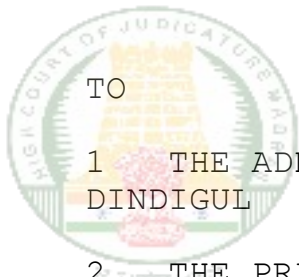
