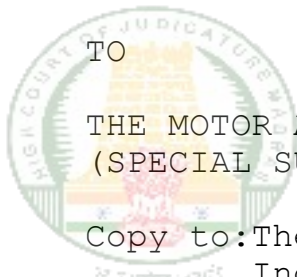

Considering the above facts, the claimant is permitted to withdraw 50% of his share in the deposited amount, along with proportionate interest and costs, without filing any formal petition before the Tribunal and the balance amount shall be deposited in a fixed deposit in the Indian Bank, Madurai Bench of Madras High Court Branch, Madurai to the credit of C.M.A.(MD).No.525 of 2014, initially for a period of one year and renewable thereafter, till the disposal of the appeal.
