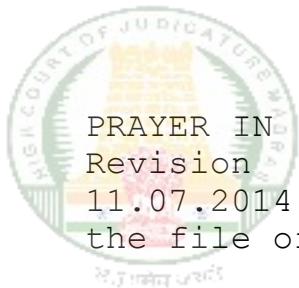
PRAYER IN CMP(MD) No.5807 of 2016:
