Prayer in CMA(MD)No.SR.44854/2014:

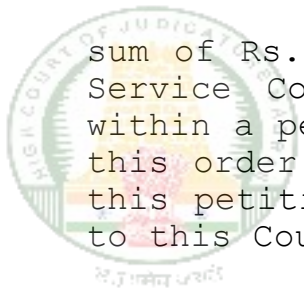
