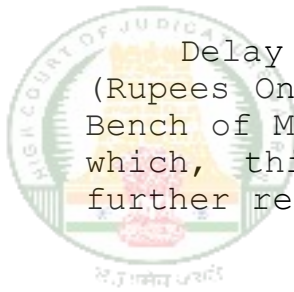
Prayer in CMA(MD) No.SR27305 of 2016:
