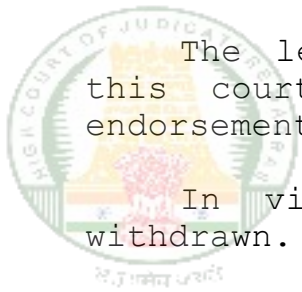
PRAYER IN CROS.OBJ(MD) No.SR363 of 2015:-
