PRAYER IN CMA(MD)NO.SR17508/2014 :

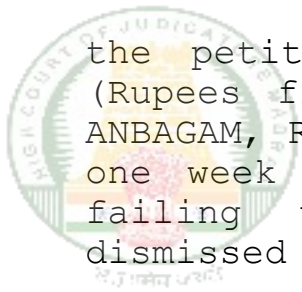
