PRAYER IN CMA(MD) No.SR11804 of 2010:

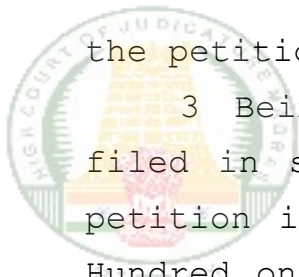
