Prayer in CMA(MD) No.SR35124 of 2016:-

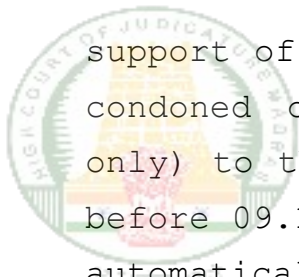
