Prayer : Criminal Original Petition filed under Section 482 of the Code of Criminal Procedure, praying to direct the second and third respondents and their subordinates not to harass or ill-treat the petitioner to demolish the wall constructed in shop No.32, Shopping Complex, A.M.C. Road, Stalin Cottage, Dindigul at the instigation of the fourth respondents.

ORDER

It is an application seeking a direction to the second and third respondents and their subordinates not to harass or ill-treat the petitioner to demolish the wall constructed in shop No.32, Shopping Complex, A.M.C. Road, Stalin Cottage, Dindigul at the instigation of the fourth respondents.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents 1 to 3.

3.The learned counsel for the petitioner would submit that the respondent Police frequently called the petitioner to the Police Station and harassed him under the guise of enquiry in respect of a civil dispute.



4.The learned Government Advocate (Criminal Side) submitted that petitioner was called only for enquiry in respect of a petition pending against him given by one Senthilkumar and not to decide the civil rights of the parties in the Police Station and that the respondent Police did not cause any harassment to the petitioner and his family members. However, he gave an undertaking that if at all the presence of the petitioner is required, the respondent would call the petitioner for enquiry only after issuing summons giving specific date, time and place.

5.Recording the above undertaking given by the learned Government Advocate, this Criminal Original Petition is closed.
