Prayer in CRL RC(MD)No.355 of 2007:-

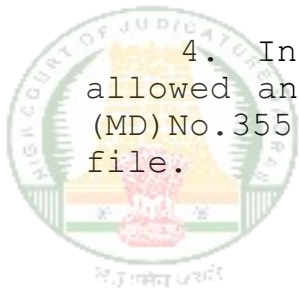
