by this Honourable Court.

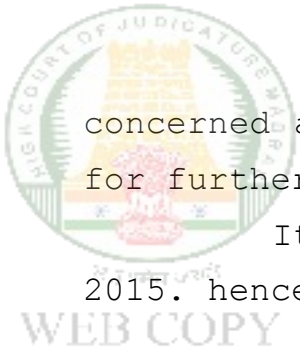
Order : This petition coming on for hearing on this day, upon
