Heard the learned counsel for the petitioner and the learned Government Advocate(Crl.Side) for the respondent.

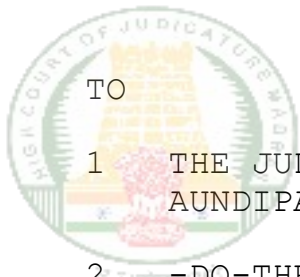
2.According to the learned Government Advocate(Crl.Side), the petitioner is complying with the conditions imposed by this Court regularly.
