2. According to the learned Government Advocate (Crl.side), the petitioner is complying with the conditions imposed by this Court regularly.

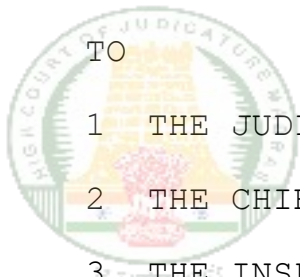
