2.This Court has perused the petition and satisfied with the reasons stated therein.

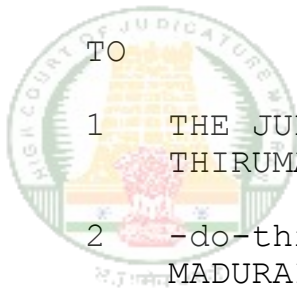
