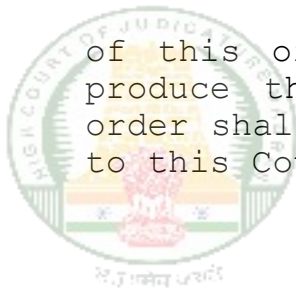

2.This Court has perused the petition and satisfied with the reasons stated therein.

3.It is represented by the learned counsel for the petitioner that since there is a delay in filing this petition, the petitioner is willing to pay costs (to be fixed by this Court), to anyone of the orphanages/trusts.

4.Under such circumstances, time for complying with the conditions imposed by this Court in Crl.OP.(MD).No.19973 of 2016 dated:19.10.2016 is extended for further period of two weeks from the date on which a copy of this order is made ready, subject to the condition that the petitioner pays a sum of Rs.2,500/- (Rupees Two Thousand and Five Hundred only) as costs to "Indian Association for the Blind, Sundarajampatty, Alagar Kovil main Road, Arumbanur Post, Madurai" within a period of two weeks from the date on which a copy



of this order is made ready. The petitioner is also directed to produce the receipt before the lower court, failing which, this order shall stand automatically dismissed, without further reference to this Court.
