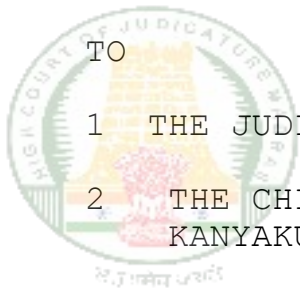
Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.side) for the respondent.
