2. It is seen that anticipatory bail was granted to the petitioner as per order dated 09.11.2016 and he was directed to surrender within fifteen days from the date of receipt of a copy of this order. It is admitted that the copy of the ordered was delivered on 15.11.2016. However, the petitioner has filed this extension petition only on 15.12.2016, ie., out of time.

3. In view of the same, ten days time is granted from the date on which the order copy made ready, to surrender before the Court concerned, on condition that the petitioner shall pay a sum of



Rs.1000/- (Rupees One Thousand Only), to the Legal Aid Serviced Authority, Madurai District. Accordingly, this petition is allowed.
