Prayer in CRL MP(MD). 12697/ 2016 :

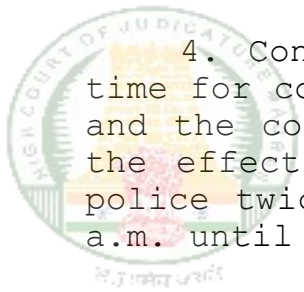
