Prayer in CRL MP(MD). 1935/ 2016 :

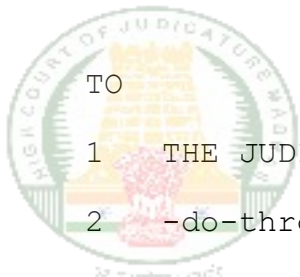
