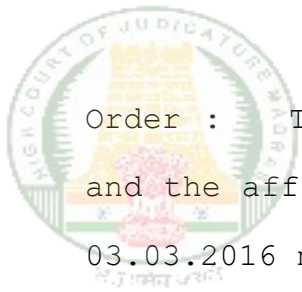
Petition filed U/S. 267 of CR.PC praying that in the circumstances stated therein and in the affidavit therewith, the High Court will be pleased to,

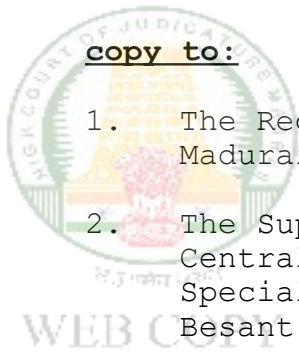
