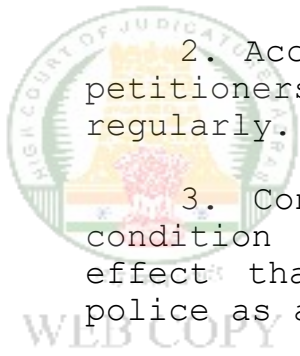
PRAYER IN CRL MP(MD)NO.2024/2016 IN CRL OP(MD)NO.24257/2015 :
