2.The counsel appearing for the petitioner would submit that, since the second respondent has not shown any interest to investigate the matter, the petitioner has come forward with this application for the relief as stated supra.

3.Resisting the same, the Government Advocate (crl.side) would submit that the investigation is going on in an effective manner and he seeks four months time to file a final report and objected the relief sought for by the petitioner.

4.Considering the facts and circumstances of the case and also considering the submissions made on either side, the Deputy Superintendent of Police, Thirumangalam Sub Division, is directed to investigate the matter and file the final report, as expeditiously as possible, preferably, on or before 15.05.2016. The Additional Superintendent of Police, Madurai Rural shall monitor the investigation.



5. The Criminal Original Petition is disposed of accordingly.
