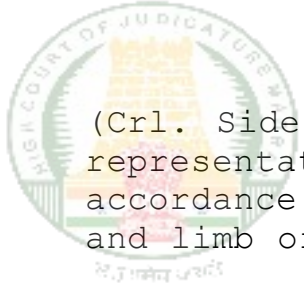
This petition is filed to provide police protection for the life and limb of the petitioner and her family members, as per the representation of the petitioner, dated 21.06.2015.
