"Allowed and Crl.OP.(MD).NO.553/2014 is restored to file".

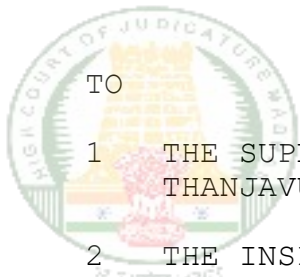
