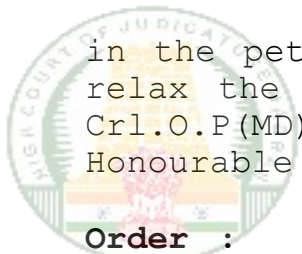
Prayer in CRL MP(MD). 2649/2016 IN CRL OP(MD) No.116/2016:
