Heard both sides.

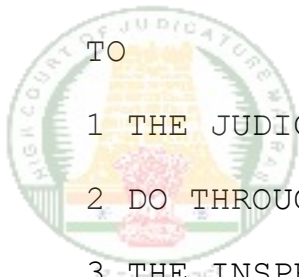
2. According to the learned Government Advocate (Crl.side) , the petitioners are complying with the conditions imposed by this Court regularly and charge sheet has been filed in the case.
