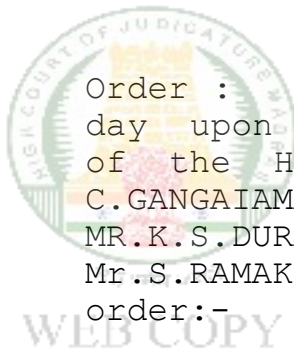

PRAYER IN CRL.MP(MD)No.3703 of 2016:
