The learned Government Advocate (Crl.side) submitted that the petitioner is complying with the condition from 14.04.2016.

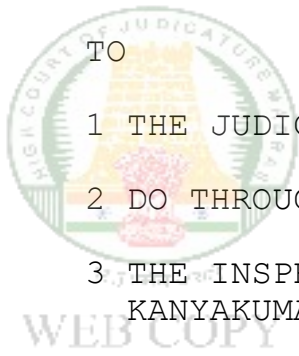
