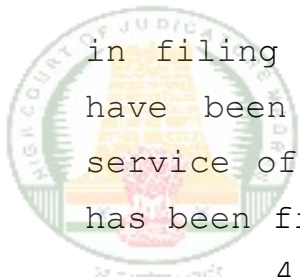

It is an application, seeking further four months time to file final report in Crime No.81 of 2013.

2.Even though notice has been served on the respondent and his name is also printed in the cause list, there is no representation on behalf of the respondent.

3.The learned Government Advocate (Crl.side) appearing for the petitioners would submit that one Muthammal, who is a witness to the case, refused to give thumb impression for the purpose of getting expert opinion and only on account of that, there is a delay



in filing final report. It is also represented that earnest steps have been taken to serve summons through Court and even after service of summons, she did not appear. Hence the present petition has been filed seeking further time.
