This petition is filed to extend the time granted to the petitioners in Crl.O.P(MD)No.8120 of 2016, dated 19.05.2016.

2.This Court, by order dated 19.05.2016 made in Crl.O.P.(MD). No.8101 of 2016 granted anticipatory bail to the petitioners and directed the petitioners to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioners did not comply with conditions, within the time prescribed by this Court. Hence, they have approached this Court with the present petition for extension of time.

3.There is no representation for the petitioners. It is averred in the petition that the petitioners could not produce the sureties within the time prescribed by this Court and hence, they pray for extension of time.
