The learned Government Advocate (Crl.side) submitted that the petitioner is complying with the condition regularly.

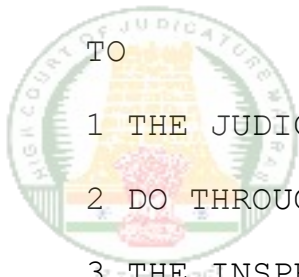
