3. Recording the said submission, this Criminal Original Petition is closed.

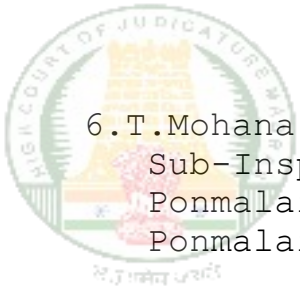
