This petition has been filed by the petitioners to relax the condition imposed by this Court in Crl.O.P(MD)No.6673 of 2016, dated 21.04.2016.

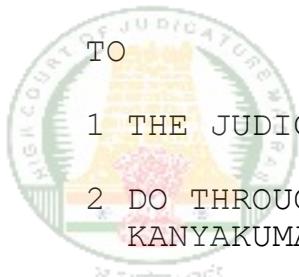
