Prayer in CRL MP(MD). 5551/ 2016 in CRL RC(MD)NO.468/2016:

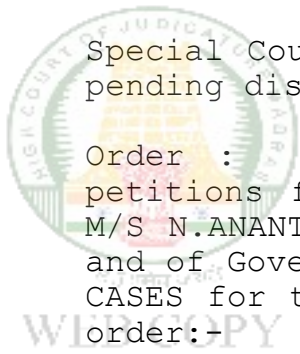
