2.The learned counsel for the petitioners submitted that the petitioners have been granted anticipatory bail with certain conditions and the petitioners have been directed to appear before the respondent police daily at 10.30 a.m. until further orders. The petitioners are complying with the condition from 08.06.2016.

3.The learned Government Advocate (Criminal side) submitted that the petitioners are complying with the condition only from 08.06.2016 to 05.07.2016 and thereafter they have not complied with the condition.

4.Considering the facts and circumstances of the case and also considering the fact that the petitioners are complying with the condition only from 08.06.2016 to 05.07.2016 and thereafter they



have not complied with the condition, this Court is not inclined to relax the condition imposed on the petitioners and accordingly this petition is dismissed.
