This Court, by order dated 15.06.2016 made in Crl.OP(MD) No.9340/2016 granted anticipatory bail to the petitioner and directed the petitioner to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioner did not comply with conditions, within the time prescribed by this Court. Hence, he has approached this Court with the present petition for extension of time.
