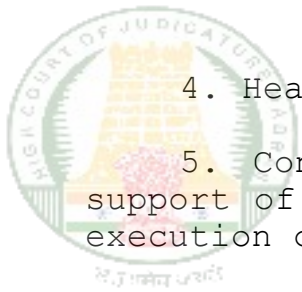

This petition is filed to extend the time granted to the petitioners in Crl OP(MD).No.6582 of 2016 dated 15.06.2016.

This Court, by order dtaed 14.6.2016 made in Crl.O.P(MD)No. 6582/2016 granted anticipatory bail to the petitioners and directed the petitioners to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioners did not comply with conditions, within the time prescribed by this Court. Hence, they have approached this Court with the present petition for extension of time.
