This Petition is filed to extend the time granted to the petitioners in Crl.O.P.(MD)No.6994 of 2016, dated 06/06/2016.

2. This Court, by order dated 06/06/016 made in Crl.O.P.(MD)No.6994 of 2016 granted anticipatory bail to the petitioners and directed the petitioners to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioners did not comply with conditions, within the time



prescribed by this Court. Hence, they have approached this Court with the present petition for extension of time.

3. The learned counsel for the petitioners contended that the petitioners could not produce the sureties within the time prescribed by this Court and hence, he prays for extension of time.

5. Considering the reasons stated in the affidavit filed in support of this petition, this petition is ordered and the time for execution of sureties is extended till 27/07/2016.
