The learned Government Advocate (Crl.Side) submitted that the petitioners are complying with the condition regularly.

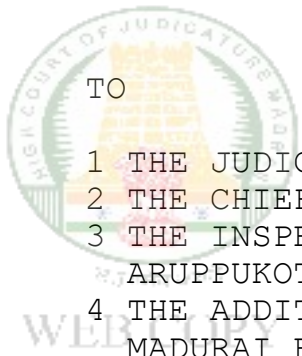
2. Considering the above submission, the condition already imposed by this Court is modified to the effect that the petitioners shall appear before the respondent police as and when required for interrogation.
