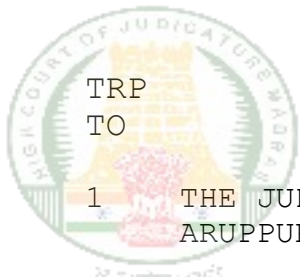
The learned Government Advocate (Crl.Side) submitted that the petitioners are complying with the condition regularly.
